

SINGAPORE PAVILION AT POSIDONIA 2020

1 to 5 June 2020 Metropolitan Expo Centre, Athens, Greece

- 1. The Association of Singapore Marine Industries (ASMI) is organising a Singapore Pavilion at the 27th edition of Posidonia in partnership with the Singapore Maritime Foundation. **Posidonia 2020** will be held from 1 to 5 **June 2020** at the **Metropolitan Expo 2**, in **Athens**, **Greece**.
- 2. This biennial exhibition is regarded as the global marketplace for ship builders, suppliers of ships' equipment and shipping-related services. A record 2,009 exhibitors from 92 countries including 22 national pavilions participated in Posidonia 2016. They occupied more than 40,000 sqm of exhibition space. Posidonia 2018 was attended by 23,527 visitors from 104 countries, making it the largest gathering in the international shipping calendar.
- 3. The 203-sqm Singapore Pavilion in Posidonia 2020 will be located in Hall 2 of the Metropolitan Expo Centre. The Location Plan for the Singapore Pavilion at Posidonia 2020 is enclosed at Annex A.
- 4. The participating costs for companies in the Singapore Pavilion are reflected in the attached 'Estimated Costings for Participation at Posidonia 2020' at Annex B. Funding support of up to 70% for eligible expenses (eg. space rental and stand construction costs) is available from Enterprise Singapore (ESG) through ASMI for participation in the Singapore Pavilion.



2.5 Pavilion Costs

a) Space Rental Rate : € 450 psm (about S\$742.50 psm)

Assume Exchange Rate of €1 = S\$1.65

b) Mandatory Exhibitor Insurance : € 1 psm (about S\$1.65 psm)
 c) Stand Construction Cost : S\$580.00 psm (budgeted)

d) Total Space Rental, Exhibitor Insurance

and Stand Construction Costs : S\$1,324.15 psm

3. OTHER FEES & CHARGES

3.1 ASMI Administrative Fee

At S\$550 for ASMI Member company or S\$700 for Non-Member company.

3.2 Pavilion Directory Cost

Estimated S\$1,000 for printing of Pavilion Directory. This is a requirement by ESG for flagship trade shows and the printing cost will be partially funded by ESG, with the balance cost co-shared by all companies in the Pavilion.

3.3 Secretariat Costs

Companies are required to co-share Secretariat costs for economy airfare and hotel accommodation with ESG. ESG will fund up to 70% of the Secretariat costs for up to 2 pax. The balance costs will be co-shared by all the participating companies.

3.4 Auditor's Fee

Estimated S\$1,000 for engagement of External Auditor to audit accounts for submission of claims for grants to ESG. This is a funding requirement and the Audit Fee will be partially funded by ESG, with the balance cost co-shared by all the participating companies in the Pavilion.

3.5 **Stand Refreshments**

Purchase of snacks and beverages, etc, for exhibitors' and visitors' consumption in the Pavilion will be co-shared by all companies.

3.6 Other Administrative Expenses

Out-of-pocket expenses incurred on behalf of the group in the Singapore Pavilion (if any) will be cost shared by all participating companies in the Pavilion.

4 **GOVERNMENT FUNDING**

4.1 Subsidy - iMAP Grant

- 4.1.1 Funding is available from ESG's International Marketing Activities Programme (iMAP) for eligible companies participating in the Singapore Pavilion.
- 4.1.2 The grant is eligible for the following expenses:
 - (a) Space Rental
 - (b) Mandatory Exhibitor Insurance (c) Stand Construction

 - (d) Pavilion Directory
 - (e) Secretariat's Airfare & Accommodation
 - (f) Auditor's Fee
- 4.1.3 The grant quantum will be up to 70% of eligible costs and for up to a maximum area of 36 sgm for each company.
- 4.1.4 The iMAP grant for Posidonia 2020 is available through ASMI only. ASMI will submit the grant claims on behalf of all companies.
- 4.1.5 The iMAP grant is given on a reimbursement basis.
- 4.1.6 Disbursement of grant will take five to six months after completion of the trade show and depending on the submission of claims.

4.2 **Double Tax Deduction**

- 4.2.1 Approved companies can deduct eligible expenses incurred twice against their taxable income.
- 4.2.2 To qualify for DTD, a company should meet the following requirements:
 - (a) A resident company or permanent establishment in Singapore,
 - (b) Is currently not enjoying any tax relief under the Economic Expansion Incentives (Relief from Income Tax) Act
- 4.2.3 DTD can be applied for qualifying expenses not covered by iMAP grant.

- 4.2.4 Qualifying or Eligible Expenses include:(a) Airfare and accommodation (up to two employees)
 - (b) Publicity Costs (corporate brochures, advertising)
 - (c)
 - Insurance for exhibits, etc
- 4.2.3 DTD will be allowed to businesses without prior approval from ESG on qualifying activities and subject to a cap of S\$150,000 per year of assessment. Companies that need larger support amount (more than S\$150,000 a year) can seek prior approval from ESG.

GENERAL INFORMATION AND TERMS & CONDITIONS FOR EXHIBITORS PARTICIPATING IN THE SINGAPORE PAVILION AT POSIDONIA 2020

1. SINGAPORE PAVILION

- 1.1 The Singapore Pavilion at Posidonia 2020 will be set up in Hall 2 of the Metropolitan Expo 2 in Athens, Greece.
- 1.2 The Singapore Pavilion (Pavilion) will be managed by the Association of Singapore Marine Industries (ASMI). The Pavilion is co-organised in partnership with the Singapore Maritime Foundation (SMF).
- 1.3 Companies in the Pavilion are participating collectively under the national (Singapore) branding.

2. FUNDING SUPPORT

- 2.1 Funding support is available from the Enterprise Singapore (ESG) under its International Marketing Activities Programme (iMAP). It will cover <u>up to 70%</u> of eligible expenses such as space rental cost, mandatory exhibitor insurance fee, stand construction cost, pavilion directory cost, secretariat cost and auditor's fee.
- 2.2 Companies wishing to exhibit under the Pavilion must meet the eligibility criteria of ESG's iMAP as well as ASMI's evaluation criteria.
- 2.3 The grant will be subject to a cap of 36 sqm for each eligible company.
- 2.4 The grant is given on a reimbursement basis.
- 2.5 All claims for grant is subject to proof of full payment made for the claimed expenses.
- 2.6 ASMI will submit the claim for grant to ESG on behalf of all companies in the Pavilion, and on condition that all outstanding invoices to ASMI, its contractors and the Show Organiser (if applicable), are fully settled.
- 2.7 An ESG-approved External Auditor will be engaged by ASMI to audit the claims for grant. The cost of engaging this Auditor will be cost-shared by companies in the Pavilion.
- 2.8 The grant will be disbursed to companies between five to six months after completion of the trade show, and depending on the submission of claims.

3. ELIGIBILITY AND APPLICATION

- 3.1 Interested company must submit the completed *Application Form for Participation as Exhibitor In Singapore Pavilion at Posidonia 2020* to ASMI for eligibility check and approval.
- 3.2 Companies which failed to meet ESG's eligibility criteria and/or ASMI's evaluation criteria will not be allocated a space in the Pavilion.

- 3.3 Once application is approved by ASMI, the company will be liable for all costs (eg, space rental, exhibitor insurance, stand construction, telegraphic transfer charges, etc) incurred on its behalf, if it subsequently decides to withdraw its participation in the exhibition.
- 3.4 Confirmation of reserved space in the Singapore Pavilion is subject to full payment of space rental cost.

4. PAVILION SPACE RENTAL AND STAND CONSTRUCTION

- 4.1 ASMI will sign the Space Rental Contract and make payment directly to the Show Organiser, on behalf of all the participating companies in the Pavilion.
- 4.2 ASMI will also sign the Stand Construction Contract and make payment directly to the appointed contractor, on behalf of all companies in the Pavilion.
- 4.3 ASMI will bill participating companies in the Pavilion for reimbursement of their share of space rental cost and basic stand construction cost and any other costs incurred on their behalf.
- 4.4 Companies are required to reimburse and make payments to ASMI by the stipulated deadlines as stated in its letter(s) and/or invoices.

5. PAVILION DESIGN

- 5.1 All Singapore Pavilions in trade shows funded under iMAP are required to follow the national pavilion branding design guidelines and funding conditions as stipulated by ESG.
- 5.2 The Singapore Pavilion will be constructed in accordance to the standard guidelines imposed by ESG for the whole pavilion including your company's booth.
- 5.3 The Singapore Pavilion will carry the standard national branding features in the overhead structures, hanging banners, pylons and fascia boards and information counters as approved by ESG.
- 5.4 The corporate name to be displayed on the fascia board should be the same as that stated in the application form for participation as Exhibitor in the Singapore Pavilion.
- 5.5 The Singapore flag will be displayed on the fascia of every company alongside its corporate name.
- 5.6 ASMI will invite one or up to three contractors to propose the pavilion design and quote for the construction of the Pavilion.
- 5.7 The Pavilion Design and Stand Construction contractor will be appointed by ASMI based on majority votes of participating companies, if two or more contractors were invited to quote for the project.
- 5.8 Participating company will vote for its preferred pavilion design and contractor, if applicable. A company will lose its voting rights if its representative is not present at the meeting in which the voting is conducted. Proxy vote is acceptable if ASMI is notified prior to the meeting.
- 5.9 The Pavilion design is subject to the approval of ESG.
- 5.10 As part of the iMAP grant condition, the 'Singapore' branding features must be maintained in the entire Pavilion, including in the individual company's stand. Companies in the Pavilion are assumed to have agreed to abide by the 'Singapore' branding requirements as they have been informed of the requirements before they apply to be in the Pavilion.
- 5.11 Companies in the Pavilion are required to adhere to the standard design of the Pavilion for consistency and image branding as a national group. Minor enhancements to individual company's stand are allowed subject to approval from ASMI and ESG.

- 5.12 Any company wishing to enhance its own stand must use only the appointed contractor. The company is required to submit a copy of its stand enhancement proposal to ASMI for approval. Failure to do so may affect the company's claim for grant if the company's stand enhancement design is deemed to have compromised the overall design and national identity of the Pavilion.
- 5.13 Additional cost incurred for company's own booth enhancement will not be funded.

6 COMMON AND OTHER EXPENSES

- 6.1 All companies in the Pavilion are required to share in the cost of engaging an ESG-approved External Auditor to audit the accounts for submission of claims for grants to ESG. The engagement of this Auditor is a condition under the iMAP grant.
- 6.2 A Pavilion Directory will be printed to feature all companies in the Pavilion as per ESG's guidelines. The cost of printing this Pavilion Directory will be co-shared by all companies in the Pavilion and ESG.
- 6.3 Companies in the Singapore Pavilion are required to co-share Secretariat costs such as economy airfare and accommodation with ESG. ESG will fund Secretariat costs at up to 70% and for up to two staff. The balance will be co-shared by companies in the Pavilion.
- 6.4 All companies in the Pavilion are required to pay an Administrative Fee to ASMI for services rendered.
- Any refreshments arranged by ASMI for participating companies and visitors calling at the Pavilion will be coshared by all companies in the Pavilion.
- 6.6 Any out-of-pocket expenses incurred by ASMI on behalf of the group in the Pavilion will be co-shared by all companies in the Pavilion.
- 6.7 All payments due to ASMI must be settled by the stipulated deadlines as stated in ASMI's invoices.
- ASMI reserves the right to revoke its approval on the company's space booking or impose penalty charges if payment due to ASMI is not settled by the specified deadline.
- 6.9 ASMI reserves the rights not to proceed with the submission of any company's claim for grant if there are outstanding payments yet to be settled by the company or if they have breached the terms and conditions of participation in the Singapore Pavilion.
